1 Statement from the Chair

An Unprecedented Year

We have all faced unprecedented challenges in the past year. With the devastation following the Memorial Day tornadoes, the inexplicable shootings in the Oregon District, a pandemic unlike any seen in 100 years, and the escalating tension due to systemic racism in our country and our community, we have been called on to come together to support each other and our community in new and urgent ways. As pediatric professionals, we have the unique opportunity to continue our steadfast commitment to partnering together to assure that all our children are raised in safe, stable, and nurturing relationships. Today, more than ever, it is vital for all of us to recognize that together we have experienced significant trauma, and be prepared to support each other, our patients, their families, and our community during these difficult times.

It has been incredibly gratifying to see our faculty and the entire family at Dayton Children's Hospital work together to live the Dayton Children's Hospital values of safety, compassion, collaboration, innovation, ownership, and value creation in response to the events of the past year. Whether by contributing to the Employee Assistance Fund to support those affected by the tornados or the pandemic, or volunteering in our neighborhood, Old North Dayton, and across the community, faculty and staff have come together.

Recognizing the longstanding disparities in access to emotional and behavioral care for children, and accelerated by the events of the past year, Dayton Children's Hospital has made a long-term commitment to expand the continuum of care for children with emotional and behavioral challenges. Under the leadership of Kelly Blankenship, DO, Chief of Child and Adolescent Psychiatry, Mary Beth DeWitt, PhD, Chief of Child Psychology, Susan Fralick, LPCC-S, Director of Community Behavioral Services, and Mindy Schultz, LISW-S, Director of Social Care Services, the Behavioral Service line has expanded dramatically. A state of the art 24 bed inpatient behavioral health unit opened in July 2019. An intensive outpatient and partial hospitalization program has been approved and will open in a new Behavioral Health Center at 700 E. Main St. in Dayton in November 2020.

Through several public and private partnerships, efforts are underway to:

- Raise awareness to reduce the stigma associated with mental health
- Expand access to parenting services
- Integrate behavioral health services in primary pediatric settings
- Support children and families coping with chronic illness
- Promote resilience in our school children
- And expand training programs

In addition, Gogi Kumar has led efforts to promote Physician Wellness and foster resilience among our faculty in these difficult times.

Rebecca Cunningham, MD, Professor of Emergency Medicine at the University of Michigan, Director of the Injury Prevention Center, Vice President for Research and Principal Investigator for Firearm Safety Among Children and Teens (FACTS) joined us for a Visiting Professorship in October 2019, highlighted by a Grand Rounds on Gun Safety over Gun Control. Shilpa Sangvai and her team in General Academic Pediatrics have partnered with the Ohio Chapter of the American Academy of Pediatrics to promote gun safety.





An incredibly talented and dedicated team led by Adam Mezoff, Chief Medical Officer, and Jayne Gmeiner, Chief Nursing Officer, worked tirelessly to prepare Dayton Children's to support our community's children and our adult hospital systems for the surge of COVID-19. Our faculty embraced the use of telehealth services overnight in order to assure that the children in our region continued to have access to high quality care.

Thankfully, the pediatric population in our region was largely spared from infection, but the necessary preventive measures had a significant impact on the day to day operations of the hospital, the pediatric practices, the schools, the businesses, and the families in our community.

Our team joined colleagues across the nation in White Coats for Black Lives. Erica Taylor is Co-Chairing a new Advisory Group for an African American Faculty Initiative. Debbie Feldman, CEO at Dayton Children's, has convened a dynamic, interprofessional Task Force on Racism. Recognizing that there are many unresolved biases in our workplace, the Task Force will recommend a comprehensive set of action steps to address biases and systemic racism in our policies, procedures,



practices and care protocols, and to identify ways in which Dayton Children's can play an active role in addressing the impact of and eliminating racism from our community.

The coming year will challenge all of us to make thoughtful, innovative, and transformational choices as we discover the "new normal."

Ongoing Commitment

Through it all, the Department of Pediatrics continues its commitment to supporting and advancing high quality undergraduate pediatric medical education, graduate medical education and continuing medical education, clinical services and research.

While our students were pulled from their clinical clerkships in March, our Faculty and staff, led by Erica Taylor, Amy Jeffers, and Rebecca Elofskey, worked diligently to prepare for their return on June 29th in a new environment of COVID screening, social distancing, personal protective equipment, and virtual learning experiences.

Ann Burke, along with her new Associate Residency Program Directors, Michelle Kiger at Wright Patterson Air Force Base and Eric Whitney at Dayton Children's Hospital, supported our pediatric residents through the uncharted territory of the COVID-19 pandemic, adapting to the drop in volume throughout the hospital, the need for new infection prevention measures, and a transition to virtual learning experiences. Many thanks to our Chief Residents, Kelsey



Kapolka, Lauren Coogle, and Amy Hammen for their leadership and innovation.

The Residency program matched 8 Air Force and 8 civilian residents in 2020. Plans for graduates of the residency in 2020 ranged from primary care in rural and urban settings to hospital medicine to fellowships in developmental-behavioral pediatrics, critical care and neonatology. Our Air Force graduates will serve families local at Wright-Patterson, in Arizona, and as far away as Japan.

We are in the process of preparing an application for our first subspecialty pediatric fellowship program in Pediatric Emergency Medicine. Under the leadership of Rick Strait, MD and Katherine Batisti, MD, our application will be submitted this fall with plans to recruit our first fellows in 2021.

Research Activities Continue to Grow

Under the leadership of Catherine Sherwin, PhD, Vice Chair for Research, a centralized Clinical Research Center opened in August 2019 at Dayton Children's Hospital. The Center brings together expertise in clinical pharmacology, biostatistics, epidemiology, budgeting and contracting, and clinical trials. In addition, Dayton Children's IRB has moved to a digital platform. Bill Spohn wrapped up his outstanding tenure as IRB Chair and Hemanth Lingadevaru will be leading the IRB going forward.



The Wright State University-Women In Science Giving Circle (WSU-WISGC) Award encourages and provides funding resources to women scientists in STEMM and respects women in academia by supporting gender equity. In 2020, the Committee selected Pinki Chowdhury, PhD, Assistant Professor of Pediatrics, as recipient of WSU-WISGC Faculty Award.

Dr. Chowdhury's work is entitled:

Epigenetic characterization of childhood - diffuse intrinsic pontine glioma (DIPG) to develop novel therapeutic strategy against this malignancy

Diffuse intrinsic pontine gliomas (DIPG) are highly aggressive, accounting for 10% of all childhood central nervous system tumors. Approximately 80% harbor mutations on lysine27 of histone-3, which forms heterotypic nucleosomes with normal, acetylated-H3K27 and colocalizes with bromodomain (BrD) proteins at sites of active transcription. BrDs are a family of evolutionarily conserved motifs consisting of four alpha-helices linked by acetyl binding sites of variable

sequences and are a potential epigenetic target for restoration of aberrant protein acetylation and gene expression. In DIPG, one subgroup of BrD that has not yet been studied belongs to the multi-domain enhancer protein p300 which express in 80% of gliomas. p300 contains a histone acetyltransferase responsible for the H3K27ac mark and serves as an essential binding partner of histones to various transcription factors. Because the epigenetic landscape of DIPG is a consequence of aberrant H3K27M/H3K27ac-mediated transcriptional activation, p300-BrD inhibitors have been suggested as a potential therapeutic target that must be urgently explored.

The goal of Pinki's proposal is to identify and characterize the p300 enhancer landscape and study its role in DIPG cell lines and primary patient samples which will provide insights toward the cell heterogeneity, mechanisms of tumor viability and involvement of tumor microenvironment to overcome chemoresistance in pediatric patients and development of novel therapeutic strategy.

From July 1, 2019 to June 30, 2020, there were 69 peer reviewed publications from the WSU Department of Pediatrics and Dayton Children's Hospital, which has doubled since 2015. There were five book chapters and 21 abstracts published during that time. Department members gave 2 international and 18 national presentations. At the end of June 2020, there were 166 active studies at Dayton Children's, including 32 new studies since July 2019. Forty-eight new quality improvement studies and 8 case reports were reviewed by the DCH IRB from July 2019 through June 2020. Dayton Children's Intermediate Quality Improvement Course graduated its 5th class in 2020.

All Pediatric Subspecialties Now at Dayton Children's



The Division of Pediatric Rheumatology was established at Dayton Children's Hospital in August 2019, assuring that all recognized pediatric subspecialties are now available to the children in our region. Dustin Fleck, MD joined us as Division Chief. Dr. Fleck was born and raised in Celina, Ohio. He completed his medical school education at the University of Toledo College of Medicine in Toledo, Ohio. Following college, he spent his pediatric residency at the University of Michigan in Ann Arbor, Michigan. He also completed his fellowship in pediatric rheumatology at the University of Michigan. Dr. Fleck

is board certified in pediatrics and pediatric rheumatology. Dr. Fleck has a special interest in treating patients with interesting and rare complex diseases.



Anne McHugh, MD joined Dr. Fleck to round out the new Division. Dr. McHugh was born and raised in Englewood, Ohio. She completed her medical school education at the University of Cincinnati College of Medicine. Following medical school, she spent her pediatric residency at Riley Children's in Indianapolis. She completed her fellowship in pediatric rheumatology at Lucile Packard Children's Hospital Stanford in Palo Alto, California.

Dr. McHugh received the American Academy of Pediatrics Section on Rheumatology 2019 Earl J. Brewer Research Award for her work entitled Profiling Behavioral and Psychological Symptoms in Children with Spondyloarthritis and Polyarthritis. The award is established to recognize a pediatric rheumatology training fellow in the US or Canada who has distinguished him/herself in an area of clinical research.

Notable Achievements

13% of the 108 students in the Class of 2019 and 12% of the 103 students in the Class of 2020 entered pediatric residencies. Multiple Department members mentored medical students in career advising and in scholarly activities. 100% of pediatric residency graduates who took the American Board of Pediatrics certifying exam in fall 2019 passed.

The Healer's Art and Finding Meaning in Medicine programs continue to be integrated into the residency program. The residency program's transition to full day continuity clinic was highlighted at the Association of Pediatric Program Director's Spring meeting in May 2019. Numerous CME activities were well received, and pediatric grand rounds are now livestreamed and available to those outside Dayton Children's Hospital.



Dayton Children's Pediatrics, which includes medical student, pediatric, and family medicine clinical experiences, moved on April 30, 2019 into the new Child Health Pavilion at Dayton Children's Hospital. Dayton Children's Pediatrics and Wright Patterson Air Force Base Pediatrics were recognized by the American Cancer Society for Excellence in Mission HPV: Cancer Free Initiative for their high HPV immunization rates.

Adrienne Stolfi, PhD., earned her Doctorate in Epidemiology from the University of Cincinnati in 2020. Adrienne's expertise in biostatistics and research design and analysis has advanced the careers of countless members of the Department over the past 22 years, while contributing so much to advancing the science of child health.

Oluwarotimi Adepoju, Mohammed Salah Agha, Merrilee Cox, and Amy Jeffers, faculty in pediatric hospital medicine, completed the inaugural board certification in their newly accredited specialty. Dr. Cox also completed a Masters of Applied Science in Patient Safety and Quality Improvement at Johns Hopkins Bloomberg School of Public Health in May 2020.









The Health Professions Affinity Communities (HPAC) program led by Jack Pascoe continues to work with urban and rural schools to promote interest in health professions by supporting students in developing their own community health projects. HPAC is now working with 420 students in 13 schools across western Ohio.





The ImproveCareNow Board of Directors announced that Shehzad Saeed has accepted the position of Clinical Director of ImproveCareNow. Dr. Saeed began his duties on May 1, 2020. Dr. Saeed has been a member of ImproveCareNow since 2010. Dr. Saeed is a Professor of Pediatrics at Wright State University, and he serves as Associate Chief Medical Officer of Dayton Children's Hospital, as well as Chief Medical Officer of the Clinically Integrated Network and Physician Lead for Patient and Family Experience. He has been a leader in the North American Society for Pediatric Gastroenterology,

Hepatology and Nutrition (NASPGHAN), including as Chair of the IBD Committee and the Public Education Committee. Dr. Saeed's focus is improving the care and quality of life of children with IBD, ensuring that they grow up to reach their full potential.

In his new role as Clinical Director of ImproveCareNow, Dr. Saeed will be responsible for providing clinical leadership to plan, develop and direct ImproveCareNow's continuous learning system to achieve breakthrough performance on the network's goals for better health, a more engaged community and faster, more meaningful research for children and families living with IBD.

Level 1 Trauma Center

The American College of Surgeons (ACS) officially verified Dayton Children's Hospital as a Level 1 Pediatric Trauma Center on November 6, 2019. This is the highest level attainable. "This verification highlights the extreme commitment that Dayton Children's trauma team, led by Jeffrey Pence, MD, trauma medical director and Lisa Schwing, RN, trauma program manager, has to every level of care in some of the most critical circumstances," said Deborah Feldman, president and CEO for Dayton Children's. "They not only treat the injuries but provide long lasting healing for body and soul. The emotional damage for both child and family can be significant so we work with the community to prevent children from getting hurt in the first place. Our trauma providers live our mission of the relentless pursuit of optimal health for every child within our reach."

The American College of Surgeons verifies the presence of the resources for optimal care of the injured patient. A few elements include:

• Continuous coverage by pediatric surgeons, and prompt availability of care in pediatric specialties such as orthopedic surgery, neurosurgery, anesthesiology, emergency medicine, radiology, internal medicine, plastic surgery, oral and maxillofacial and critical care

- Continuing education of the trauma team
- Organized teaching and research effort to find new innovations in trauma care
- Prevention and public education programs for the community

U.S. News and World Report Best Children's Hospitals



Pulmonology and Orthopedics were recognized in the U.S. News and World Report 2020-2021 Best Children's Hospitals rankings released 14th annual on June 16. 2020.
