Statement from the Chair

Faculty and staff are the foundation of our education and research successes. This year, we welcomed two new members to our team and welcomed-back two former colleagues.

Amanda Hinson-Enslin, Ph.D., M.P.H. was hired as an assistant professor in health promotion and education and Camille Edwards, M.P.H. joined as the director of public health workforce and community engagement and will guide the department's expansion of workforce development and alumni engagement activities. The department also welcomed back biostatistics Professor Ramzi Nahhas, Ph.D. and Sheri Gladish, M.D., an assistant professor in aerospace medicine.

We also celebrated the retirements of three senior faculty – Drs. Robert Carlson, Sharon Sherlock, and Mary White. Their wealth of experience and knowledge will be missed.

Academics

Faculty and staff of the education center offer the Master of Public Health degree along with six certificate programs. Forty M.P.H. students, including one dual degree student (M.D./M.P.H.), enrolled during the 2019-2020 academic year. The program generated 784 graduate credit hours and graduated 20 M.P.H. students. The department also implemented new recruitment strategies including virtual open house events and the Boonshoft Public Health Workforce Scholarship for employees of local public health departments.

A major accomplishment of the education center faculty and staff was the accreditation of the Master of Public Health program by the Council on Education for Public Health (CEPH). Over 10 community partners, 14 alumni, and 13 students participated in the successful site visit.

As a result of the COVID-19 pandemic, classes and operations were moved into remote delivery modes in March. The department held a virtual graduation recognition ceremony and created a video to celebrate our M.P.H. students' accomplishments. Both faculty and students eagerly await the time when they can celebrate these accomplishments in person.

Research

The department's research centers conducted work related to substance use, behavioral health, and disabilities. The faculty and staff of these centers directed 13 grants totaling over \$2.6 million in annual expenses. The research teams made 21 national, state, and local presentations. Research faculty also took more active roles in the education center including co-teaching courses and supervising student research capstones.

Looking forward, the department's vision is to be recognized as the leader of population and public health initiatives within the university and across southwest Ohio. Goals for the upcoming year include rebuilding research efforts through new partnerships and mentoring junior faculty, expanding public health education programs, and expanding workforce and community engagement activities.
