Statement from the Chair

Despite being socially distanced from one another for most of the academic year, our team of faculty, staff, and students worked together to provide quality education and research. We learned new ways to use technology to accomplish our work and found creative ways to stay connected.

The pandemic changed us and we, in turn, will change the way we operate. As we move into the next academic year, we take with us our enhanced technology skills and our appreciation for in-person interactions. We are building more technology-enhanced outreach and learning activities and will continue to support to our local public health agencies.

Academics

The department implemented numerous new recruitment strategies, including launching a digital marketing campaign and filming an alumni video. We eliminated the extra program fee for department courses and implemented a new holistic admissions and consideration process. We hosted 10 virtual M.P.H. open house events and appreciated the participation of numerous faculty and alumni.

We also welcomed the inaugural three recipients of the Boonshoft Public Health Workforce Scholarship and selected three additional public health employees for the 2021-2022 awards. In addition, faculty member Ken Dahms provided a generous gift to create the new Master of Public Health Scholarship. In Fall 2021, the department will host our first alumni giving campaign in support of the scholarship fund.

Thirty-eight M.P.H. students, including one dual degree student (M.D./M.P.H.), enrolled during the 2020-2021 academic year, and the program graduated 9 M.P.H. students. The department held a virtual graduation recognition ceremony to celebrate our M.P.H. students' accomplishments at the end of the Spring 2021 semester. Many families, friends, and pets attended the virtual celebration, making the event particularly special for all those attending.

Research

The department's research centers conducted work related to substance use, behavioral health, and disabilities. The faculty and staff of these centers directed 20 grants totaling over \$4.6 million in annual expenses. The research teams made 15 national, state, and local presentations. Research faculty also took more active roles in the education center including co-teaching courses and supervising student research capstones.

Faculty and students also assisted five local public health departments with COVID-19 case investigation and contact tracing. We hired and trained 60 Wright State students from several disciplines to work as contact tracers and team supervisors. At the project's peak, our students provided over 500 hours a week of investigation and contact tracing.

Looking forward, the vision for PPHS is to be recognized as the leader of population and public health initiatives within the university and across southwest Ohio. Goals for the upcoming year are to expand the amount and type of department research and grow enrollment in public health education programs. We will continue to look for opportunities to operate more centrally, expand marketing and community outreach, and explore ways to contribute to a more equitable community.

Summary of Service Activities

M.P.H. Courses - Community Service Projects

The M.P.H. program has two courses designed to provide practical public health experience via service-based learning to M.P.H. students.

Students in PPH 7410 Community Assessment worked as a team to complete a project for a community agency identified needing a health assessment. The instructor provided the guidance and didactic content necessary to complete the assessment and the community agency provided frequent input. Students are required to have both quantitative and qualitative components in the assessment

and to make recommendations based on their findings. In 2020, classes conducted a pediatric injury assessment for Dayton Children's Hospital and a men's health assessment for Public Health - Dayton & Montgomery County.

Students in PPH 7440/7920 Public Health Project Management course created and presented a program plan for Re-Imagining America: Dayton, Ohio who needed a program plan for assessing the need and acceptance of well-care in Miami County, Ohio. The instructor provided content and learning activities associated with program plan development. The program plan consisted of a work balance structure, Gantt chart, staffing plan, two job descriptions, SWOT analysis, risk analysis, risk matrix, and recommendations for implementation.
